The Principals of all Affiliated Colleges in Arts, Science, Commerce and Technology and Director, University Sub Campus (Thane & Ratnagiri) /Heads of University Departments are hereby informed that the Board of Deans at its meeting held on 9<sup>th</sup> November, 2021 vide an item No.9.6 in the matter of granting permission to accord "Equivalence for IB Career Programme (IBCP) on par with Grade 12 and AIU equivalency received for the IBCP Programme as similar to IBDP", resolved that :

"Concerned AIU guidelines are adopted as per the norms approved by Association of Indian Universities, New Delhi.(Annexure-2) and it was also resolved that the e provisional admission will be given to the students on the basis of provisional mark sheet subject to declaration of final result"

**The Annexure-2 i.e. the AIU Norms are as follows:**


**IBCP equivalence for General Strand (Arts, Science, Commerce, Law)**

- (a) Students graduating with 02 DP subject with at least 01 subject at HL Level and minimum 03 points in each DP subject.
- (b) Career Related Study (CRS) with at least 03 subjects offered by IB authorised partner like World Academy of Career Programme and its Associates.
- (c) International Baccalaureate Career Related Study (IBCP) qualification with core components requirement awarded by International Baccalaureate (IB).

**IBCP equivalence for Engineering or Medicine Strand**

- (a) Students graduating with 03 DP subjects (Math, Physics, Chemistry, Biology or other similar subjects) with at least 01 subject at HL Level and minimum 03 points in each DP subject.
- (b) Career Related Study (CRS) with at least 03 subjects offered by IB authorised partner like World Academy of Career Programme and its Associates.
- (c) International Baccalaureate Career Related Study (IBCP) qualification with core components requirement awarded by International Baccalaureate (IB).

You are therefore requested to note the contents of the circular while admitting the students for various Undergraduate/Professional courses in the Affiliated Colleges/Recognised Institutions/ University Departments etc. from the academic year 2022-23. They are also requested not to admit any student without Prima Facie Letter from Admissions, Enrolment, Eligibility and Migration Department (AEM).
